

# Annual statement on compliance with IPC practice (including cleanliness) for General Practice Template

## **Purpose of the 'Annual statement'**

The Health and Social Care Act 2008: code of practice on the prevention and control of infection and related guidance requires the Infection Prevention and Control (IPC) Lead to produce an annual statement. We have conducted our own audits for IPC purposes. These include Hand hygiene, Sharps management, Waste disposal, PPE, Cold chain procedures & Decontamination of equipment.

Legionella (water safety), Waste management, Sharps injuries, COSHH (Control of Substances Hazardous to Health)

## 4. Staff training

All staff members at the surgery complete annual mandatory IPC training.

Sadie Newton and Matthew Brown completed the Infection Prevention and Control training update. (8 hrs of training completed by both Sadie and Matthew in September)

## 5. IPC Policies, procedures and guidance

All IPC Policies reviewed September 2025, including:

Viral gastroenteritis, Specimen collection, Safe management & care of the environment, Safe management of sharps & inoculation injuries, Safe management of care equipment, Safe management of blood & bodily spillages, Safe disposal of waste including sharps, PPE, Outbreaks of communicable diseases, Notifiable diseases, Multi-resistant gramnegative bacteria including carbapenemase, MRSA, Invasive devices, Infection control policy – SICPs and TBPs, Hand hygiene, C. Diff, BBV, Aseptic technique, Antimicrobial stewardship.
